## Safety

## 

Working with unfamiliar equipment can lead to careless injuries. Read and understand this manual and the manual for your vehicle before assembling, installing, operating, maintaining, servicing, removing, or moving this Danuser Intimidator. If there is anything in this manual you do not understand, contact your dealer or Danuser LLC. The safe use of this attachment is strictly up to you, the operator. If this attachment is used, loaned, or rented by any other person, it is the owner's responsibility to make certain that the operator prior to operating:

- Reads and understands the Operator's Manuals
- Is instructed in safe and proper use
- The Intimidator is designed to be operated from the vehicle seat. Do not operate with another person near or in contact with any part of the Intimidator. Keep others 100 ft. (30.5 m) or more away from the Intimidator.
- All operators of this attachment must read and understand this entire manual, paying particular attention to safety messages and operation instructions, prior to assembling, installing, operating, maintaining, servicing, removing, or moving the Intimidator.
- Please remember it is also important that you read, understand, and follow the safety signs on the attachment. Clean or replace all safety signs if they cannot be clearly read and understood. They are there for your safety as well as the safety of others. Danuser LLC will furnish new safety signs upon request at no charge.
- All things with moving parts are potentially hazardous. There is no substitute for a cautious, safeminded operator who recognizes potential hazards and follows reasonable safety practices.
- Personal protection equipment including hard hat, safety glasses, safety shoes, gloves, and ear plugs are recommended during assembly, installation, operation, maintenance, service, removal, or movement of the attachment.
- Never check pressurized system for leaks with your bare hand. Wear proper hand and eye protection and use wood or cardboard when searching for suspected leaks. Oil escaping from pinhole leaks under pressure can penetrate skin and create a serious medical emergency. If any fluid is injected into the skin, gangrene, blood poisoning, even death may result. - Safe operation of equipment requires the operator's full attention. Avoid distractions such as radio headphones, cell phones, etc. while operating.

### Safety

- Do not dig near underground utility lines.
- Stay away from power lines when transporting, raising, or operating the attachment. Electrocution can occur without direct contact.
- The Intimidator must be securely latched to the vehicle. Ensure both locking handles are in the locked position with pins fully seated. An improperly latched Intimidator can fall without warning.
- Before you operate the attachment, check over pins and connections to be sure all are securely in place.
- Make sure all guards are in place and secure before operating equipment.
- Keep hands, feet, hair, jewelry, and clothing away from all moving parts.
- Never place yourself between the vehicle and the attachment.
- Never allow anyone under the attachment at any time.
- Never place any part of your body between the jaws of the attachment. Such moving parts can crush or sever, resulting in serious injury or death.
- Operate the attachment only with a vehicle equipped with a Roll-Over Protective Structure (ROPS). The vehicle must be equipped with an operator enclosure that will provide a safe operating area.
- Do not exceed the vehicle's rated operating load. Use sufficient counterweights. Move the vehicle slowly when the attachment is raised.
- Be aware of tree limbs and other debris entering the operating area of the vehicle.
- Reduce pulling force once the item starts to loosen from the ground. Large items that require high pulling force can cause the vehicle to become unstable if the item suddenly breaks loose or the jaws slip.
- Be sure the load does not stick out too far. A light load sticking out too far can have the same tipping effect as a heavy load carried in close.
- Carry the load low. A heavy load can cause instability of the vehicle. Use extreme care during travel. Slow down on turns and watch out for bumps. Use all safety devices, including a seat belt, as recommended in the vehicle operator's manual.
- For operator safety, always keep the load in front of the vehicle. Load should never be tilted toward or positioned over the operator.
- Objects grasped in the Intimidator can shift or fall, causing serious injury or death. Keep others 100 ft (30.5 m) or more away from the Intimidator.
- Be aware of a falling tree or limb hazard. A tree that has lost part of its root structure or limbs can fall at any time.
- Do not operate the Intimidator on steep hillsides. When operating the Intimidator on uneven or hilly terrain, position the vehicle with the attachment uphill. With the attachment downhill, the vehicle could tip when attempting to raise the Intimidator. Consult your vehicle operator's manual for maximum incline allowable.

- Always shut off the vehicle engine, remove the key, lower vehicle arms, and relieve all hydraulic pressure before dismounting the vehicle. Never leave equipment unattended with the vehicle running.
- Never attempt adjustments, service, or repairs while the equipment is in operation.
- Never work under equipment supported by hydraulics. Even with the vehicle shut off, equipment can suddenly drop if controls are actuated or if hydraulic lines burst.
- Before connecting or disconnecting hydraulic lines or fittings, be sure to relieve all pressure by cycling all hydraulic controls after shutdown. Remember hydraulic systems are under pressure whenever the engine is running and may hold pressure after shutdown.
- Store the attachment on a flat, level surface in an area where children do not play. Securely block and support the attachment.
- Do not modify the attachment. Modifications may weaken the integrity of the attachment and may impair the safety, function, life, and performance of the Intimidator.
- When making repairs or servicing the Intimidator, use only parts that meet original equipment manufacturer's standards and requirements.

## Hydraulic Requirements

### **Filtration Requirements:**

• A filter of, at least, 10 micron filtration is required.

**NOTE** The life of the hydraulic componentry is almost entirely dependent upon cleanliness of the oil. Instructions in your vehicle operator's manual regarding filter and oil changes should be carefully followed. Even small amounts of dirt in the hydraulic oil can cause premature hydraulic componentry failure that is not covered by warranty.

### Pressure and Flow Requirements:

• The Intimidator is designed to operate up to 3,500 PSI.

### **Hydraulic Fluid Selection Requirements:**

- Premium grade petroleum based fluids will provide the best performance.
- Fluids that contain anti-wear agents, rust inhibitors, anti-foaming agents, and oxidation inhibitors are recommended.
- The viscosity of the fluid should never fall below 70 SUS (13 cST). The best viscosity range for the Intimidator is 100-200 SUS (20-43 cST).


### Prepare the Vehicle

Read and understand the manual for your vehicle before assembling or installing the Intimidator. The vehicle must be equipped with either a skid-steer quick attach hitch, Euro/ Global quick attach hitch, or a hitch to which the Flat Back Intimidator has been customized, auxiliary hydraulics, a Roll-Over Protective Structure (ROPS), and an operator enclosure. The use of the Intimidator may require the addition of counterweights to ensure the combined weight of the attachment and load does not exceed the rated capacity of your vehicle.

**NOTE** For the Flat Back Intimidator, consideration must be given to the customized mounting setup. The vehicle mount must be constructed with sufficient strength to safely handle the loads generated during the operation of the Intimidator. Make sure to position the Intimidator to allow space for hydraulic hose connections and routing of the hoses.


Recommended Tools

- 3/4" wrench (2)
  1/2" wrench (2)
- Metal band cutter
  - Grease gun

- STEP 1: The Intimidator is shipped in a vertical position on a pallet as illustrated below. Lower the Intimidator to a horizontal position on a flat, level surface.




STEP 2: Using a band cutter, remove the banding from the attachment. Remove the pallet.

STEP 3: Pull hoses out from between the brush guard and the frame. Using two 3/4" wrenches, remove the four 1/2" bolts and nuts (1), and loosen the two 1/2" bolts (2).



STEP 4: Rotate the brush guard into the vertical position, and secure with bolts and nuts from STEP 3. Nuts must be torqued properly; refer to *Torque Values Chart*.



STEP 5: Route the hose couplers and hoses through the welded hose routing guide.




Euro/Global models do not have welded hose routing guide; skip to STEP 6.

# Assembly & Installation

(continued)



Keep hands, feet, hair, jewelry, and clothing away from all moving parts. STEP 6: Using two 1/2" wrenches, loosen the hose clamp assembly. Route the hydraulic hoses through the clamp assembly, and reattach the hardware. Nut must be torqued properly; refer to *Torque Values Chart*. Place the hoses and couplers over the brush guard to avoid trapping them between the attachment and the vehicle.



- STEP 7: Grease the zerk located on each jaw.
- STEP 8: Park the vehicle on level ground, and install the Intimidator by following your vehicle operator's manual for installing an attachment.



The Intimidator must be securely latched to the vehicle. Ensure both locking pins are fully seated. An improperly latched Intimidator can fall without warning.

STEP 9: Connect the hydraulic hoses to the vehicle's auxiliary hydraulic outlets. Test the vehicle to make sure you have enough hose length to perform the full range of the loader arms' operating heights.



Before connecting or disconnecting hydraulic lines or fittings, be sure to relieve all pressure by cycling all hydraulic controls after shutdown. Remember hydraulic systems are under pressure whenever the engine is running and may hold pressure after shutdown.

NOTE

Ensure quick couplers are clean prior to connection.



Hose routing is the responsibility of the operator. Pinched and/or stretched hoses are not covered under the warranty.

- STEP 10: Engage the auxiliary hydraulics to make sure the jaws of the Intimidator open and close freely.
- STEP 11: Check the hydraulic system for leaks.



Never check pressurized system for leaks with your bare hand. Wear proper hand and eye protection and use wood or cardboard when searching for suspected leaks. Oil escaping from pinhole leaks under pressure can penetrate skin and create a serious medical emergency. If any fluid is injected into the skin, gangrene, blood poisoning, even death may result. Obtain medical attention immediately.

STEP 1: Remove any obstructions preventing safe access to the post, tree, etc. ("item") being removed.



The maximum size of tree that can be removed will vary depending upon the soil conditions, size and species of tree, and the size of the vehicle.

- STEP 2: Lower the Intimidator close to the ground, and tilt the jaws slightly downward.
- STEP 3: Activate the auxiliary hydraulics to open the jaws. Drive slowly forward until the item is between the jaws. Do not use the Intimidator to grasp items that you do not want marred from contact with the jaws.



Never place any part of your body between the jaws of the attachment. Such moving parts can crush or sever, resulting in serious injury or death.



Be aware of tree limbs and other debris entering the operating area of the vehicle.

- STEP 4: Activate the auxiliary hydraulics to close the jaws, securing the item.
- STEP 5: Raise the Intimidator slowly, using the vehicle loader arms to remove the item from the ground. If additional force is needed, slowly drive the vehicle forward while pulling.

Operation		<b>AWARNING</b>
(continued)		Reduce pulling force once the item starts to loosen from the ground. Large items that require high pulling force can cause the vehicle to become unstable if the item suddenly breaks loose or the jaws slip.
		<b>AWARNING</b>
		Do not exceed the vehicle's rated operating load. If necessary, use sufficient counterweights.
	NOTE	The Intimidator should be used while driving the vehicle forward. Do not drive backwards to pull items. Repeatedly driving backwards while pulling items can damage the Intimidator or vehicle coupler. Such failure and resulting damages are not covered under warranty.
	STEP 6:	If unable to pull the item, open the jaws, back away, and fully close the jaws. Use the bucket teeth located on the front of the jaws to excavate around the item, digging under any roots holding the item.
	NOTE	Ensure the jaws are closed prior to digging or prying. Failure to do so can damage the Intimidator. Such failure and resulting damages are not covered under warranty.
	STEP 7:	Once the item is loosened, open the jaws and repeat the process to pull the item.
	STEP 8:	Intimidators equipped with side-saw-teeth jaws may cut items in addition to pulling them. The teeth are bi-directional and will cut while driving the vehicle either in forward or reverse. If sawing is preferred over pulling, fully close the jaws and position the vehicle such that the Intimidator side-saw-teeth come in contact with the item to be cut off, near the front of the jaws.
	STEP 9:	Ensure the jaws are parallel to the ground, then slowly drive the vehicle forward. A single pass can remove up to 6" of material. In order to cut an item larger than 6" in diameter, repeat STEP 8 on the opposite side of the item. Take care to saw such that the cut item will fall away from the vehicle.
	STEP 10:	Slowly transport the item to the desired location with the jaws tilted slightly downward, carrying the load at the minimum height required for transport.
		For operator safety, always keep the load in front of the vehicle. Load should never be tilted toward or positioned over the operator.
		<b>AWARNING</b>
		Carry the load low. A heavy load can cause instability of the vehicle. Use extreme care during travel. Slow down on turns and watch out for bumps. Use all safety devices, including a seat belt, as recommended in the vehicle operator's manual.

# Removal & Storage



Never allow anyone under the attachment at any time.



Personal protection equipment including hard hat, safety glasses, safety shoes, gloves, and ear plugs are recommended during assembly, installation, operation, maintenance, service, removal, or movement of the attachment.

# **ACAUTION**

Always use two people to handle heavy, unwieldy components during assembly, installation, maintenance, service, removal, or movement of the attachment.

## Troubleshooting

Before storage, the Intimidator should be thoroughly cleaned, washing off all dirt and grime. Make sure the hydraulic system is properly sealed against contaminants entering the unit. Always store the Intimidator in a dry, covered location.

- STEP 1: Lower the Intimidator onto a flat, level surface in an area where children do not play.
- STEP 2: Disconnect the hydraulic hoses from the vehicle's auxiliary hydraulics.



Before connecting or disconnecting hydraulic lines or fittings, be sure to relieve all pressure by cycling all hydraulic controls after shutdown. Remember hydraulic systems are under pressure whenever the engine is running and may hold pressure after shutdown.

- **NOTE** Connect the quick couplers together to prevent contaminants from entering the Intimidator's hydraulic system.
- STEP 3: Follow your vehicle operator's manual for removing an attachment. Securely block and support the attachment.
- STEP 4: Tighten any loose nuts, bolts, and hydraulic components.
- STEP 5: Replace any damaged or missing safety signs.
- STEP 6: Lubricate the grease zerks and coat the exposed portion of the cylinder rod with grease to prevent rust.







Left Jaw Pivot Point - 1 Zerk






